From April 1st 2006 to December 31st 2007 in Commercial Merori, SL, dedicated to computer supplies wholesale mainly, being in charge of the administration department as a head, the functions included preparation of financial statements, cash management, billing supervision, stock control, purchasing negotiations, management and verification of import documentation and monitoring them untill be cleared and delivered to our wharehouse, as well as coordination with external consultancy services for various outsourced services regarding tax and labor issues.
 - 2. From May 8th 2006 to December 31st 2014 in Commercial Adocse, SCP, a retail company initially dedicated to selling computer supplies, and later, with a total change of focus, trading other sort of products such as wine, cava or olive oil, amongst others. In this company I was the CEO, and also a partner of it, being in charge of all management functions, including amongst others preparation of financial statements, cash management, billing supervision, purchasing negotiations, as well as coordination with external consultancy services for various outsourced services regarding tax and labor issues. I also took on directly building the "on-line" store and several social networking accounts linked to the store and intended for its promotion (blog, facebook, twitter and google +).
 - 3. From February 1st 2011 to March 1st 2012 in Spainproducts, S.L. a company dedicated to selling products through ecommerce and a traditional shop, the function was to update and then manage their online store operating under spaingoods.com domain, an ecommerce specialized in selling typical spanish products, mainly wine and iberian ham, as well as creating various social networking accounts intended for its promotion (blog, twitter and facebook)..

- From February 2nd 2.000 to March 31st 2.006 at the company Even Gestion, S.A., dedicated to the design and manufacture of promotional marketing gadgets, being in charge of the administration department, reporting to the CFO, amongst the functions were included preparation of financial statements, management and verification of import orders documentation and also monitoring them (including formalities with customs broker and logistics service companies) until delivery of goods to customers, as well as coordination with external consulting services about several different outsourced issues regarding tax and labor issues. At the same time I had assigned the task of monitoring and final acceptance of the installation and start up of computer network and management applications as well as the corporate website, phone and email services, staying later as a contact person with the suppliers of these services in charge of managing incidents that arise and prepare requesting and supervise the implementation of modifications, extensions or adaptations that over time they needed.
- From January 1st 1.995 to September 5th 1.997 at the company Autoservicio Quelco, S.L. (the company which took over part of the business and personal of Autoservicio Camumar, S.C.P.), dedicated to the operation of the supermarket located inside the "Camping Toro Bravo" Viladecans (Barcelona), being in charge of the accounting department, cash management, stock control and products purchasing, as well as coordination with external consulting services about several different outsourced issues regarding tax and labor matters.
- From March 1st 1992 to December 31st 1994 at the company Autoservicio Camumar, S.C.P. dedicated to the operation of servies of bars and restaurants, as well as the supermarket, located inside the "Camping Toro Bravo" Viladecans (Barcelona), being in charge of the accounting department, cash management, stock control and products purchasing, as well as coordination with external consulting services about several different outsourced issues regarding tax and labor matters.
